




A meeting of this grievance redressal cell on the grounds of the complaint received from the students of department of Physics 17/08/17.

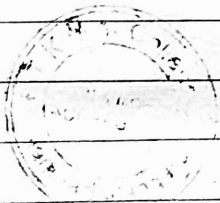
As per the complaint given lodged by the students of department of physics, the department has been levying a fine of Rs 100/- from UG students and Rs 200/- from PG students.

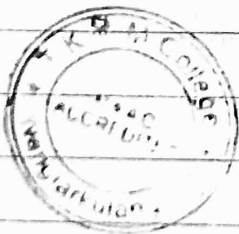

REPORT OF GRIEVANCE REDRESSAL CELL

2017-2018

The Grievance Redressal Cell for students was constituted in the beginning of the academic year. Smt. Mini R selected as the convenor, Smt. Seena V, Smt. Bindu B, Dr. Ratheesh R, Dr. Venu S and Smt. Divya P Bhadrans were selected as the members of the committee.

Four grievances were considered by the committee in this academic year. The first meeting of the cell called to order on 17/0/17 to resolve the complaint filed by the students of department of Physics regarding the heavy fine for mobile phones and committee has resolved the complaint by suggesting the department to reduce the fine amount. The second meeting was conducted on 30/0/2017 as per the complaint lodged by the lady representatives of the college union regarding the insufficient mugs and buckets and the cell instructed the PTA to do the needful. The third meeting conducted to resolve the complaint filed by a student from the department of Mathematics for the revaluation of internal examination answer script and cell instructed the concerned department to re-evaluate the answer script and found no change in the marks. The fourth meeting of the Cell conducted on 12/10/2017 based on the complaint filed by the students of Department of Physics for the postponement of internal examination on the grounds of incompleteness of portions.
